# **SUMMARY**

2023 was a year of transition for the ISDRS. After the impactful Covid years, we have been working on the ISDRS organization which has led in 2023 to some decisions and changes that prepare our society for the future. Board members are motivated to take on tasks and challenges to make our society stronger.

Thanks to a selected and dedicated team of board members, the journal project has been

developed as a major focus for our society besides the conference.

The conference hosts of ISDRS 2023 built on the hybrid experience from the 2022 conference in Stockholm while reaching out to local and regional sustainability scholars. In the end, we had a very successful experience with 331 participants roughly half on campus and half online, a diverse group of keynote speakers and a high number of traditional and new tracks. With this positive experience in Malaysia, we are looking forward to our next conference in Nepal.

The membership base seems to stabilize with the group of followers still increasing. The institutional members have decreased. All in all, we will review our membership system to improve it for the years to come.

At the end, the board was very happy with the positive outcome and evaluation of ISDRS 2023. Many scholars of the ISDRS community are very active and we are happy to see members aiming for publications in books in our ISDRS Routledge Series on Sustainable Development Research and special issues in several journals.

This takes the number of women to eight of twenty-one, the number of people based outside of Europe to nine of twenty-one, and mostly from high-income countries. We are grateful to the Election Committee for their work identifying potential new board members and preparing the elections.

On Dr Olwale Olayide exiting as Secretary late 2023, Prof. Simon Lockrey was elected as Treasurer from January 1st 2024.

# **EXECUTIVE COMMITTEE AND BOARD**

During 2023, we saw some rotation among the executives of ISDRS. New incoming from January 1, 2023 were Gyula Zilahy as Vice President, Marlen Arnold as Treasurer, and Prajal Pradhan as Director of Communications. And from October 1, 2023 Sjors Witjes stepped up as President surpassing Peter Dobers, who became Past President as of the same date.

The board assistant continued providing a critical continuity over the years, and ideally will do next time as well during 2023.

#### INDIVIDUAL MEMBERSHIP

ISDRS has two categories of Memberships – Individual and Institutional. Institutional members are equivalent to individual members (e.g. eligible to stand for office, and vote).

ISDRS Conference fee includes membership – so everyone who registers and pays for the conference becomes a member if they weren't one already. Conferences are an opportunity to increase the number of individual members. Memberships should be explicitly offered to non-member delegates when they register for the conference. Offering membership (for GDPR reasons) to non-member delegates is

required for them to know that they are joining ISDRS. Instead of a 'non-member' conference fee, switch to a 'conference plus membership fee'.

Individuals benefitting from institutional members will have to identify themselves and registeron the website for ISDRS to get an idea (& count) who they are.

Current membership rates are Euros 95 (high income economies), Euros 55 (for other economies and PhD students), and Euros 20 (other economies students).

The number of paying members joining directly through the ISDRS website appears to have declined this year (Table 3). This reflects ongoing issues in determining the precise number of members. This year also the non-member fee explicitly includes membership for the 12 months following payment (also estimated in Table 3). Note that the number of individuals shown as members includes members benefiting from an institutional membership (see below). We have a total membership of 291 persons including board members.

The discount rate for the conference was changed from its previous basis of whether the country of residence is a member of OECD to whether or not it is a high-income country in the World Bank classification. This will also be changed on the ISDRS website for those joining/renewing directly as individuals or institutions.

The number of followers (registered on the website but not paying) has increased.

This is good of course, but we need to be careful to avoid calling followers 'members'. There is confusion amongst the followers as to whether they are or are not members. For example, non-members have volunteered for roles (such as the audit committee), despite the call for volunteers explicitly stating that only paying members were eligible.

#### INDIVIDUAL MEMBERSHIP

Currently ISDRS has 6 institutional members as compared to 8 last year (and 16 in 2020-2021) (Table 4). If the maximum number of individuals at each institution took up their right to register on the ISDRS website, this would provide 57 members. More than 12 have claimed the members' discount for the conference, however. It will in due course be possible

to identify those individuals and either contact them to encourage them to register, or (if allowable under data protection rules), manually register so that they have to opt out ratherthan opt in to receiving the newsletter

#### **Discrepancies and Uncertainties**


The following summarises remaining discrepancies and uncertainties related to the ISDRS financial information for 2023:

 I membership opportunities and a diamond open access journal platform. The ISDRS board is confident that the Society's financial position remains sound and is exploring opportunities to invest in future growth, particularly through enhanced membership opportunities and a diamond open access journal platform.

#### COMMUNICATION

This section highlights the activities of the communications section of ISDRS since the last conference. The communication channels engaged during this period include the quarterly newsletter, LinkedIn group, Facebook, Twitter, Instagram, website posts, and blogs.

The periodic newsletter goes to all members

and followers and has continued consistently, with two issues released in 2023 (Table 8). The editorial committee members (Prajal Pradhan and Marlen Arnold) continued overseeing and supporting the making of the newsletter with assistance from Waqas Mazhar. The social media platforms were used continuously for promotional purposes and to elicit feedback from readers. Keyvan Hosseini is now assisting with ISDRS social media and managing the Instagram and

Facebook pages. With slightly increased membership (including followers), we would be able to significantly increase and improve our outreach without much expense.

The number of subscriptions to the newsletter has increased while the proportion of active engagement (clicked and opened) remained static. The number of recipients unsubscribing remains low. An issue with Mailpoet meant that only a proportion of members and followers were receiving the newsletter. This is now resolved. The list of subscribers has been updated during 2024.

The ISDRS LinkedIn group has continued to increase from 3080 in 2022 to 3180 in 2023. LinkedIn engagement has increased due to greater content being shared and the promotion of the newsletter on LinkedIn. During the month of May 2023, post views increased by 53% compared to the previous month. Whereas, the comments and reactions remained low throughout the year.

The Facebook membership count stayed at 1.6K in 2023. Keyvan Hosseini is now managing the Facebook page, and the number of posts has increased significantly in the 2022 period, resulting in increased followers. The ISDRS New Professionals Group (NPG) Facebook page has had no activity in 2023. Moreover, NPG groups have also been created on LinkedIn which is managed by Saurab Biswas, Hanna Ahlstrom, Agnieszka Stefaniec, and Waqas Mazhar.

Similarly, the number of Twitter followers increased from 718 in 2023 to 751 at April 2024. The followers on Instagram have increased from 289 in 2023 to 295 in April 2024. The activities of social media reflect the potential to get more promotional value when pursuing this more actively. We still require members (especially board members) to demonstrate more support by 'liking' and reposting messages and targeting posts they send ISDR social media handlers. There is also a request with the call for Newsletter content to provide social media content and a new ISDRS media email has been set up (socialmedia@isdrs.org). While the social media team has been finding content to use, only a small amount has come from members or board members. We have the support in place for improving ISDRS social media, we just need members to provide content.




Figure 2: Facebook page visits by country

Facebook statistics include demographic information, such as the top countries visiting ISDRS Facebook page, see figure 2. ISDRS has recently increased Facebook posts by linking them to Instagram. The NPG group page needs a lead person managing this.

Most engagement on ISDRS's twitter feed happen during the conference, see figure's 3 and 4. The most impressions from a tweet in 2024 was from the announcement of 2024 conference. It reached to 631 impressions. This is because the winner shared within their network and the tweet reached further engagement. This is evidence of the benefits of sharing tweets among members networks.

#### **TOPIC GROUPS**

Topic Groups of ISDRS based on the United Nation's Sustainable Development Goals have not been changed from previous years as they form the backbone of discussions at conferences and other ISDRS related activities.

Currently 9 themes (+1 special theme for the year) including 26 Topic Groups form the basis of Tracks at the annual conference.

Additionally, an exceptionally high number (5) of special Tracks were announced for the Conference in Kuala Lumpur in Malaysia, of which only one (Sustainability in Africa) has been organised before:

- 1. Sustainability and Africa
- 2. Sustainability and ASEAN
- 3. One health, SDGs, and ethical conflicts
- 4. Religion and Sustainable Development
- 5.ICT for Sustainable Development in IR4.0 Era

Special Tracks either concentrated on topics especially relevant to the Host and the South East Asian region or on emerging issues relevant to all delegates.

A high number of Track Chairs assisted the work in each Track, many of them personally present at the conference. In Tracks where no international Track Chair could attend off-line, local Track Chairs facilitated the discussion.

On-line meetings for Track Chairs have been organised by the Vice President, which served with useful information to Chairs as well as a platform for informal discussion.

Prior to the Conference, Track Chairs were motivated to reconsider the objectives of their Tracks and with a few exceptions, Topic Group descriptions were updated based on their suggestions.

#### **CONFERENCES**

#### **ISDRS 2023 Conference**

The 29th annual ISDRS conference was held between July 11-13, 2023 in Kuala Lumpur, Malaysia and gathered researchers from all continents through-out the world within the field of sustainability, in a total of 331 registrations. The theme for the 2023 conference was "Half-way through Agenda 2030: Assessing the 5Ps of SDGs (people, planet, prosperity, peace and partnership)". A happy team at Universiti Kebangsaan Malaysia (UKM) under the leadership of associate professor Rasyikah Md Khalid created a very welcoming and memorable event.

A detailed conference website has been created (https://2023.isdrsconferences.org/) and associated conference proceedings. 331 participants made it to the hybrid conference roughly half on campus and half online. With strong support by many sponsors at UKM such as The Faculty of Law UKM, UKM Graduate School of Business, UKM Strategy Center, The Institute of Malay World and Civilization, UKM Centre for IDEA, The Fuel Cell Institute UKM, Institute of IR4.0 UKM, Institute of Climate Change and Institute of Islam Hadhari. ABSTRACT. The development of societies, including spiritual development, is closely connected to forests. The larger interrelations among changing societies, transforming forest landscapes, and evolving spiritual values related to forests have yet to be extensively considered. Addressing this research gap is important to avoid the neglect of spiritual values in forest policy and management. Our exploratory study investigates spiritual values of forests from European and Asian perspectives, assessing 13 countries. Based on expert knowledge from 18 interdisciplinary experts, we first define forest spiritual values (forest spirituality). We then elaborate on the idea that forest spirituality evolves as societies and landscapes change, and propose a transition hypothesis for forest spirituality. We identify indicators and drivers and portray four stages of such a transition using country-specific examples. We find that during a first stage ("nature is powerful"), forest spirituality is omnipresent through the abundance of sacred natural sites and practices of people who often directly depend on forests for their livelihoods. ## **NETWORKING ACTIVITY**

Our networking and participation at events hosted by partner organisations consisted online meetings and conferences, including at the 29th ISDRS Conference. We foresee improvements and flexibility and further opportunities for networking in the near future, as travel returns to normal post pandemic and as more events are now held in hybrid (physical and online) format.

#### **ELECTIONS**

In 2023, the Election Committee organised three rounds of elections to fill the vacant positions in the executive board. According to the Charter, the Election Committee consists of two or three members of the Board and the Executive Secretary as chair. The members of the Election Committee for 2023 were: Olawale Olayide, Prajal Pradhan, and Olga Cam. The Election Committee ensures that eligible members are invited to stand for nomination to the board, prepares a proposal to the board aiming at a balanced selection of nominees, reflecting the diversity, considering the required size of the board and formally required executive functions (making a total of 21 members and an honorary member). Below are the results of the 2023 ISDRS elections.

All standard board roles remained the same for 2023, as they were within the tenured timeframe i.e. 2023-24, so no standard board elections were held. The next standard board election will take place in 2024.

A new executive board position being considered, in terms of publications. Considering the board is exploring a new diamond access journal, and also see a need for a role to engage with other publishing outlets as separate to the Director of Communications. This will require a change to the Charter, which is being explored by the board in 2024.

# SUSTAINABILITY OF ISDRS

We need to continue to work hard at promoting the annual conference, which is both our most conspicuous activity, an important activity for inclusion and can be an excellent source of revenue. Further, the board has been working hard at the idea to expand the important research activity of conferences, by exploring and deciding upon the funding of a new and vibrant open access publication platform, which is planned to be launched in 2024.

Look out for more information. We also need to continue to refine the membership systems to enhance/protect income and to enhance our communications with members to enhance our retention rate. We will work continueously to involve the ISDRS New Professionals Group in conference preparations. In sheer numbers, the PhD Day at ISDRS online conference 2023 was successful, with about 50 PhD students participating. This growth of the number of young scholars taking part in the PhD Day, including the first round of mentorship program during 2021, is very promising to the long-term sustainability of ISDRS.

## **ROLE OF THE ASSISTANT**

In 2023 the Assistant's role continued at 2 days per week, however they contributed considerably more than the contacts hours. Charlotte Mummery's time in 2023 was divided according to Table 8. Responsibilities in 2023 have included support for the conference organising committee.

Waqas Mazhar has taken over the assistant position since December 2023, dedicating twelve

hours per week to various society tasks. The duties listed are in accordance with operations of the society. However, areas of priorities have been suggested. These include updating official ISDRS website, improving database, and supporting 2024 conference organizing committee.

The duties listed are all vital activities in our given style of operation, although improvements have been suggested such as improvements to the membership database, and to our website. Keyvan Hossein has been handling social media communication, such as Instagram, YouTube, and Facebook, for the past few months. Keyvan is very creative and has made some impressive social media posts. However, unless board members, members and followers promote these activities, they will not have the desired impact.
